Cancellations and Amendments

All cancellations or amendments must be in writing and a confirmation email received from Knockderry House. Whilst every effort is made to fulfil any requests which you may have in relation to your stay with us, we cannot unfortunately guarantee that we will be able to meet any requests which you may make and our failure in this regard will not constitute a breach of contract.

Best Available Rates : If you cancel your stay more than 7 days prior to your arrival, we will not charge you for cancellation. However should you cancel with less than 7 days till your check in date we will charge you the full cost of your stay.

Flexible Rates : If you cancel your stay more than 3 days prior to your arrival, we will not charge you for cancellation. However should you cancel with less than 3 days till your check in date we will charge you the full cost of your stay.

Advance Purchase Rates : The full price of the stay is due at the time of the booking and is non refundable or transferrable.

Business Rates : All reservations must be confirmed in writing by email. For short stays, of less than 7 days, no deposit is required but for stays 7 days or more in length we may require a deposit of 25% of the total stay. All bookings are required to be guaranteed with a valid credit or debit card at the time of booking. Cancellation Charges. If your stay is cancelled within 48 hrs of arrival, a cancellation charge equal to the total cost of the first night's stay, will be due.
